## Rules for 4-H/FFA Members & Open Exhibitors Under the age of 18

1. Anyone staying overnight must be a 4-H/FFA member or open exhibitor under 18 showing an animal at the Beaver Community Fair.
2. All 4-H/FFA Livestock animal exhibitors and open exhibitors under 18 must be present Sunday, September 18, 2016, at 7:00 pm, in the show arena for an overnight meeting. Any member not attending will not be permitted to stay at the fair overnight.
3. All 4-H/FFA dairy animal exhibitors must be present Monday, September 21, 2015 at 7:00 pm in the milking parlor area for an overnight meeting. Any member not attending will not be permitted to stay at the fair overnight.
4. A chaperone will be present and in charge of each animal building. Per each night.
5. All 4-H/FFA members & open exhibitors under 18 will need to check in with the chaperone at a designated time and place. This will be announced at the meeting.
6. A barn curfew will be 10:00 pm, with the lights out at 11:00 pm. All members must be in their designated barn as checked on the overnight consent form turned in to the office.
7. The overnight consent form needs to be filled out and turned into the office no later than Sunday, September 14, 2014. All information must be filled in properly and signed by both parents/guardians.
8. If any 4-H/FFA member & open exhibitor under 18 do not follow curfews, rules, regulations or destructs fair property, the member's parent/guardian will be contacted to pick up the member and will not be able to stay overnight the rest of the fair week.
9. All 4-H/FFA members & open exhibitors under 18 filling out an overnight slip must stay in the designated barn. Members are not permitted to stay in vehicles or trailers.
10. Beaver Community Fair does not assume responsibility for the actions of the 4-H/FFA members & open exhibitors under 18 who do not abide by these rules.
